The Seller, Banks Rocks LLC, an entity owned by GL Rogers Co. of Portsmouth, NH, was represented by <u>Kent White</u> and <u>Caitlin Burke</u> of The Boulos Company. White and Burke had been handling the leasing of the property for years and played a critical role in preparing the property for a sale.

Presently, medical tenants occupy 90% of the building. The buyers intend to fill the entire property with medical tenants, achieving 100% occupancy. Additionally, they plan to invest in upgrading the building's exterior and mechanical systems, elevating it to Class A standards. This renovation will not only enhance the building's aesthetics but also its functionality, further solidifying its reputation as one of the premiere medical office campuses in the market.
